





A Message From Our CEO

Over 15 years ago, I walked through the doors of JVS Toronto for the first time and found a community of like-minded people driven by a passion for helping others. I have seen many changes, new programs and new faces, but the deep and meaningful impact we have on the people we serve is one thing that has not changed. Now in our 75th year of service, I continue to be incredibly proud of our Agency's resilience and responsiveness.

Last year, over 13,000 individuals, each with their own unique story, came to JVS Toronto in search of support. While they all shared a common goal of finding meaningful employment, each represented much more than just a number in our database. Every person had individual needs and barriers to employment that impacted their journeys.

Even though employment rates across the country are improving, the most vulnerable in our community continue to struggle. The declines in mental health we suffered have not recovered to pre-pandemic levels. In fact, Statistics Canada reports that one in three Canadians indicated that their mental health has gotten worse. The Ontario Nonprofit

Network reported in 2022 that 81% of social service organizations across the province have seen an increase in demand this past year. Workers hardest hit by the pandemic, such as individuals from lower-income communities and those unable to work from home, are still struggling to get back on their feet and are turning to organizations like ours for help.

We were collaborating with our community partners across the GTA to continue to address the impacts of COVID-19 when the war in Ukraine began. It forced millions to flee their homes and seek refuge in other countries. To date, JVS Toronto has supported almost 450 Ukrainian newcomers as they build new lives in Canada. Targeted employment services and a new language training program are preparing refugees for entry into the Canadian labour market.

Together with community agencies, including Canadian Ukrainian Immigrant Aid Society (CUIAS) and Jewish Immigrant Aid Services (JIAS), we are providing a full spectrum of wrap-around support for these individuals. We are also partnering with employers, like IBM Canada, Loblaw Companies Ltd., and Atlantic

Packaging Products, to host hiring events that will provide meaningful job opportunities to those who need it most.

JVS Toronto was founded to help Holocaust survivors and refugees find employment in Canada after the Second World War. While the scope of our services have expanded to the broader community over the years, our commitment to serving newcomers remains unwavering. Whether we are responding to crises occurring on a global scale, or addressing the needs of our local community, we remain committed to a highly individualized approach to breaking down barriers and helping our clients achieve self-sufficiency.

I am proud to have taken on the role of Chief Executive Officer at JVS Toronto as we celebrate the remarkable impact our Agency has had over the past 75 years.

I am proud of our incredible staff who consistently demonstrate innovation and have amazing ability to connect with, guide, and uplift those who need us most.

I am proud that there continues to be a place for everyone at JVS Toronto.

Celebrating 75 Years Est. 1947

On June 16, 1947, JVS Toronto opened its doors to the public and began helping Holocaust survivors and veterans of the Second World War find employment. At that time, Canada would only allow skilled labourers to immigrate into the country. As part of the Tailor Project, Max Enkin and a group of Jewish business leaders travelled to Displaced Persons Camps in Europe. If the survivors they met with could sew a buttonhole, they were considered skilled tailors and permitted entry into the country. As a result, 2,000 Jewish garment workers came to Canada to rebuild their lives.

After the war, the labour market in Toronto was thriving. Work ethic and experience

mattered more, education less; men made up 75 percent of the workforce, and one wage earner could manage the family's expenses.

JVS Toronto worked with other Jewish agencies
– partnerships that continue today – to provide
settlement and employment programs to the
Jewish community. Building on our success,
we expanded our services to support all
individuals in need of employment, creating
pathways to more fulfilling lives.

75 years later, JVS Toronto continues to honour our history by meeting the needs of an everchanging world. Today, women make up half of the workforce, jobs rely more on technology

and, more recently, hybrid workplaces have become commonplace. Recently, the challenges brought on by the global pandemic further changed how we view the future of work, yet also exacerbated inequities in the labour market. Significant barriers continue to threaten the livelihood of many individuals in our community, mostly those working in low income or precarious positions.

At 75, our legacy continues, and now, more than ever, we remain committed to our vision that every individual has opportunities for employment.







Nancy Chicas knows what it means to face life's challenges. Her family immigrated to Canada from El Salvador when she was just two years old. Due to learning issues and family displacement, she did not finish high school. She has experienced homelessness and has been a single mother to two young boys, both of whom are on the autism spectrum and have their own learning difficulties.

Nancy wanted a career that would make a difference in her community. After applying to the Social Service Worker program at Seneca College, Nancy was referred to JVS Toronto's **Psychology and Career Services Division** where she worked

with a Career Counsellor to discover her strengths and manage the challenges she would face as a post-secondary student.

During counselling, Nancy was always engaged and ready to learn. Since then, she has completed her first year at Seneca and is excelling in her first work placement as a co-facilitator at an after-school program for youth. She is feeling "really positive about where I am in my life right now. I feel like a contributing member of society."

David Patel* has a Bachelor's degree from the University of Toronto and a Research Analyst Certificate from Humber College. He also has Autism Spectrum Disorder (ASD) and has challenges with eye contact, socializing, and understanding non-verbal communication.

For individuals with ASD, it can be difficult to find employers who can recognize their strengths. David sent out many job applications, but had difficulty getting past the interview stage.

Through the **ASD Job-Readiness Program**,
David practiced his communication skills in
mock interviews. He also learned to network



on LinkedIn, and connect with employers to ask for informal meetings and interviews.

The support that individuals need in order to overcome barriers to employment often goes beyond simple resume assistance. JVS Toronto offers highly specialized programs based on each job seeker's unique needs, allowing them to build self-confidence and realize a path to a brighter future.

Always optimistic, David kept moving forward and his hard work paid off. Today, he is working as a Banking Clerk with the Girl Guides of Canada.



When Kanwardyal "KD" Singh was preparing to leave India and relocate to Canada, he enrolled in **Canada InfoNet**, our pre-arrival program for immigrating professionals. Through the program, he learned to create a Canadian-style resume, update his communication skills, and was matched with a mentor in his field of product management. It was that mentor who helped him land his first job in Canada just 2 months after arriving.

Many people would have been happy with that outcome and moved on with their new lives, but not KD. He wanted to pay it forward, so he came back to Canada InfoNet to volunteer as a mentor supporting other international professionals like himself.

Over the past two years, KD has helped 20 immigrants and their families through the challenging process of relocating to a new country. His mentees are always thankful for his guidance and praise his mentorship skills.

In addition to volunteering at Canada InfoNet, KD is a true program ambassador. He represents JVS Toronto at events and actively promotes our services through his own social media. Not only does KD supports his mentees, his dedication and compassion serves our whole Agency.


